**IN 2023 THE RONALD MCDONALD CARE MOBILE WAS APPROVED TO PARTICIPATE WITH THE HEALTH FIRST ALLEN COUNTY PROGRAM IN AN EFFORT TO PROVIDE GREATER MEDICAL CARE ACCESS TO UNDERSERVED POPULATIONS.
